Media Restrictions:

All work must be original. No mass-produced items.

Only recent work should be submitted.

All submission must be complete, clean, dry and professionally presented.

Please note requirements for some media:

1. **Printmaking:** must be hand printed, signed and numbered.
2. **Ceramics:** work from commercial molds is not acceptable.
3. **Jewelry:** must be designed and manufactured by the artist. Work from patterns, published books or magazines are **not** acceptable.
4. **Two-dimensional artwork:** original work only. Framed and ready for hanging is advised and required.
